

PROTOCOL OF INTENTIONS
about scientific and other cooperation acceptable for

Embassy of the Socialist Republic of Vietnam in Ukraine of the
and
the Institute of vegetable and melon
National academy of agrarian sciences of Ukraine

Paragraph 1

The aim of intentions

Joint research in the direction: vegetable and melon crops selection - exchange of linear and varietal material for environmental assessment and use in research, breeding work (cucumber, watermelon, tomato, sweet pepper, eggplant, etc.)

2. Organization of mutual conferences, symposiums, workshops and other scientific meetings

3. Joint discussion and publication of scientific research results in the public domain

4. Internship and participation in advanced training programs for researchers, graduate students

5. Implementation of the results of joint scientific projects and programs;

6. Exchange of delegations of specialists to solve scientific problems related to the implementation of provisions of the Protocol

7. Implementation, by agreement, of other joint actions aimed at deepening cooperation between the Parties and non-contradictory with the valid legislation of the countries

Paragraph 2

Sphere of activities

1. To promote the developing of innovational activity and international cooperation

2. The scientific basis implementation for agricultural sectors development

3. To create of joint industry scientific and technical programs

4. Other by mutual consent of the Parties

Paragraph 3

Execution

In the case when the participants of Intentions do not agree with separate paragraphs of Protocol of Intentions, comprehensive measures are taken to coordinate them. Areas of cooperation should be agreed through the carrying out of consultations and negotiations among the signatories of Protocol.

Paragraph 4

Settlement of disputes

Any settlements of disputes, which emerged about the questions of interpretation or realizing of such Intentions, have to be regulated through the consultations and negotiations.

Paragraph 5

Funding and Resources

The Parties agree to make efforts to find additional sources of funding for successful Protocol implementation.

Paragraph 6

Privacy

Each Party shall not disclose any confidential information of the other Party or any confidential information relating to cooperation to any third Party or its employees without the prior written consent of the owner of the confidential information.

Paragraph 7

Term of validity, continuance and ending.

Represented Intentions come into force from the moment of their signature and acting for five (5) years.

Each Party can finish the action of Intentions by written notification to another part not late as before part for six (6) months till the moment of finishing.

Abeyance of action of Intentions cannot be interdiction for finishing of any program (action) which was started in accordance with represented Intentions.

Paragraph 8

Amendments to the Protocol of Intentions

The Protocol of Intentions may be amended, supplemented or otherwise modified only by mutual written consent of Parties.

The Protocol of Intentions is made in three copies: in Ukrainian, Vietnamese and English. All texts have equal power.

It is done in Kyiv on 27 october, 2023 in tree copies by Ukrainian, Vietnamese and English languages with the same meaning of text of all languages.

The English language is working one.
